

## **WRAP**



**WRAP** is a family-driven, strengths-based team approach to working with families. WRAP uses a high-fidelity wraparound model in their work to strengthen families and support them in keeping their children at home in the community. While no single entity can respond to the complex needs of youth with serious emotional and behavioral challenges, we create a single point of accountability to serve youth and families in the community. In WRAP, we provide support to youth and families that need more intensive supports than typically available in outpatient treatment. Services include intensive in-home care coordination and connects families to community resources.

WRAP houses many of the programs at CHRIS 180 that are based in the wraparound model and fall within the Community Programs Department:

RISE PROGRAM (Real Impact for Stability and Empowerment) provides intensive, communitybased supports for youth with a high level of behavioral health needs to promote stability and overall wellness in the community using a team approach that combines clinical intervention, behavioral support and intensive care coordination. To be eligible, youth must have active Amerigroup Georgia Families 360 insurance. Youth must also have at least one or more of the following: current or recent psychiatric hospitalization, two or more placement moves within the past six months, risk of disrupting current placement, recent diversion from PRTF admission, or currently displaying a high level of needs despite ongoing services. This program covers Fulton, DeKalb, Gwinnett, Newton, Clayton, Douglas and Cobb Counties.

WIN GEORGIA provides highfidelity wraparound support for youth and families in need of more intensive levels of support. High-fidelity wraparound is a care planning process to help youth and families achieve their goals and support youth in remaining in the community. Key components include monthly child and family team meetings, coordination of services, and crisis and safety planning. To be eligible, youth must be ages 6 to 18, have a severe emotional behavioral health diagnosis, experiencing severe harm to self or others (including high-risk behaviors), placed out of home at least once in the past year, and tried lower levels of care and continue to demonstrate a high level of need. Accepts clients statewide with Medicaid, CMOs, private insurance and those who are uninsured.

**PSSF** (Promoting Safe and Stable Families) targets families in crisis that either currently have, have had or are at risk of Division of Family & Children Services (DFCS) involvement. We provide crisis intervention, therapy, parent education, life skills, and behavior management supports in addition to case management and care coordination. To be eligible, families must have a history of DFCS involvement in the past six months, a current open DFCS case, or at risk for DFCS involvement. There is no cost to this program as it is funded under a grant that covers Fulton, DeKalb and Gwinnett Counties.
